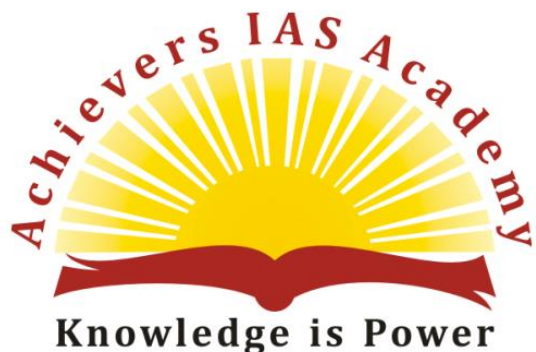
Appointments

- Two flight tests of the indigenously developed Sanrt Anti-Airfield Weapon were conducted by the DRDO and IAF, the tests were conducted on October 28 and November 3 respectively from IAF aircraft at Chandan ranges in Jaisalmer. The 2 tests were conducted using 2 different configurations Satellite Navigation and Electro-optical sensors, the SAAW is capable of carrying a warhead weighing 125 kilograms with a precision target hitting range of 100 kilometers.

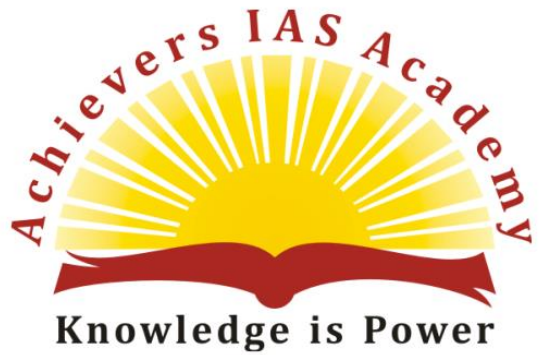

The Chief Minister of Karnataka Mr. Basavaraj S Bommai launched the 'Janasevaka' scheme and 'Janaspandana' an integrated public grievance redressal system, the 'Janasevaka' scheme will help people get doorstep delivery of all government services while the 'Janaspandana' is a one-stop platform for citizens to raise any complaints on any government scheme or services. A total of 58 government services can be availed in the 'Janasevaka' scheme by using the Aadhaar card, cast or income certificate, the scheme was implemented in the Dasarahalli area in 2019 and is now launched in the entire Bangalore city.
